This programming was created with a DTXTREME III Module. All modeling will work in DTX900, 900M modules. Be sure to UPDATE your firmware to version 1.04 (available as of 3/26/2014) if you haven't done so already.

Please take a moment to read all of our procedures below before attempting them.

If you have questions before attempting any of the procedures below, please refer to your DTXTREME III owner's manual.

It is strongly recommended to familiarize yourself with the loading procedures for your Yamaha DTX module right now. We assume you know what you are doing and have done this before for your own backup and management needs. Contact Yamaha customer support for any specific questions you might have. V Expressions LTD does not have this DTX equipment on hand.

#### Section I: Setting Slider Levels

**Step 1**: Set all sliders (KICK / SNARE / TOM / CYMBAL / HI-HAT / MISC) to 80%. Put Master Volume and Phone Volume to MIN. Work VOLUMES up from there AFTER you load files.

### Section II: Format USB Drive in Module (new drives only)

Insert USB Drive into Module

Step 1: Press: FILE Step 2: Press: F5 Format

Step 3: Name Volume Label: (make it easy like, "A")

**Step 4:** Press <SF1> (EXEC), Then Press: YES (format operation will begin)

## Section III: Moving files to your USB Drive

Insert USB drive you formatted (or the one you use for backups on this module) into computer.

Step 1: Locate root directory of USB Drive. After Formatting, there should now be an AUTOLOAD folder present.

Step 2: Locate file(s) you purchased:

- GMS\_SNGL.T3K
- TAMA 02.T3K
- PRMR\_03.T3K
- YAMA\_900.T3K
- DW 05.T3K
- ROGR 06.T3K
- (or) VEX 900M.T3K (all kits)

Step 3: Copy/Paste, or Drag, the file(s) into the root directory of USB Drive.

Step 4: Verify file(s) have been saved to USB Drive.

Step 5: Properly Eject Drive from computer.

Troubleshooting: If you are getting a format disk error message on your computer: Reformat the USB drive on the DTXTREMEIII. USE a new USB drive, not a recycled/previously used drive if this continues. Contact Yamaha customer support for a list of approved devices. If after replacing USB Drive, this procedure fails and cannot read the drive without formatting/ or you continue to get a Format Disk message; Update your firmware from Yamaha if possible. Call Yamaha Customer Support for further assistance.

## Section IV: Loading to Module



Insert USB Drive into Module (loading a SINGLE KIT) 900 modules

For a DTXTREME III - Steps 2 & 3 might need to be reversed.

Step 1: Press: FILE

Step 2: File Type: Scroll to "ALLKIT" or "KIT"

Step 3: Press: F2 LOAD

Step 4: Cursor arrow over to file and select your kit/combo using the arrow buttons

**Step 5:** Press Enter, & Kits 1-6 will contain your kit(s) purchased. Scroll to find your purchased kit(s).

Step 6: Press EXEC (SF1) & KIT (your file) is selected. Choose destination kit to be overwritten.

Step 7: Press EXEC (SF1). Process will complete

**Step 8:** Repeat Steps 4 through 7 to load any additional kits you purchased.

Step 9: Press Drum Kit when done

### Insert USB Drive into Module (loading the COMBO)

For a DTXTREME III – Steps 2 & 3 might need to be reversed.

Step 1: Press: FILE

Step 2: File Type: Scroll to "ALLKIT" or "KIT"

Step 3: Press: F2 LOAD

Step 4: Cursor arrow over to file: VEX\_900M.T3K & Select using arrow buttons

Step 5: Press Enter, & Kit 1: GMS Record is selected

**Step 6:** Press EXEC (SF1) and KIT 01 (Whatever name it is ) is selected. Choose any user kit you want. This is your destination kit and will be overwritten.

Step 7: Press EXEC (SF1). Process will complete

Step 8: Repeat Steps 5 through 7 to load all 6 drum kits.

Step 9: Press Drum Kit when done

These kits will load into User positions that you select. You can select one of these kits to come up at startup by pressing: UTILITY, (SF4) STARTUP, Scrolling the kit to your USR position, Then press STORE.
